#### MINUTES OF THE REGULAR MEETING OF THE BOARD OF LIBRARY TRUSTEES OF THE COOK MEMORIAL PUBLIC LIBRARY DISTRICT

#### April 19, 2022

<u>Call to order</u>: The regular meeting of the Cook Memorial Public Library District was held on Tuesday, April 19, 2022 at the Aspen Drive Library, 701 Aspen Drive, Vernon Hills, Illinois. President Wendy Vieth called the meeting to order at 6:30 p.m. Trustees present at roll call in addition to Ms. Vieth were: Jim Larson, Phyllis Dobbs, Karen Singer, Nate Johnson, Kristen Palic, and Deb Ader.

Staff members present were Library Director Dave Archer, Finance Director Russ Cerqua, and Executive Assistant Gabriella Pantle.

#### Public Comment: None.

<u>Approval of Minutes:</u> Ms. Ader made a motion, seconded by Mr. Larson to approve the minutes of the regular meeting of March 15, 2022. Roll call was as follows: Ayes; Ms. Vieth, Mr. Larson, Ms. Dobbs, Ms. Singer, Mr. Johnson, Ms. Palic, and Ms. Ader. Nays; none. Motion carries.

**Building Project Discussion and Approval of Resolution 2021-2022/20:** Mr. Archer first provided an update noting that at the March 15, 2022 board meeting, Trustees discussed the various alternates associated with the Window and Paver Replacement Projects. At that time, it was decided to eliminate the dedicated drop-off lane alternate in the amount of \$107,655 but to proceed with the other alternates presented. Trustees unanimously approved contracts 01-05 as shown in the Letter of Bid Award Recommendation in the amount of \$423,506. Approval of the remaining contracts was deferred to the April meeting so adjustments could be made for the removal of the dedicated drop-off lane.

He noted further that it was discovered after the meeting that the paver replacement component of the project was actually part of the drop-off lane alternate that had not been approved. Therefore, in order to proceed with the paver replacement project, a revised alternate which strips out the drop-off lane will need to be approved. The cost of the paver replacement project is \$47,545.60 which is reflected in the documentation provided by Featherstone. Approval of the resolution being presented tonight will authorize execution of revised contracts 07-09 in the amount of \$106,585 which includes reduced scope due to the elimination of the drop-off lane. He also confirmed that details of this update and the resolution were discussed with Library attorney Jim Ferolo who approved of the steps taken to change the scope of the project in accordance with bidding statutes.

Mr. Featherstone then joined the meeting via Zoom and showed a revised diagram without the drop-off lane at the Aspen Drive Library. He also went over the budget summary prepared by Mr. Cerqua, the updated Bid Tabulation Sheet, Budget Bid Analysis and Letter of Bid Recommendation prepared by Featherstone.

Ms. Singer then made a motion, seconded by Ms.Ader to approve Resolution 2021-2022/20 accepting bids and awarding contracts for the window and paver replacement projects. Roll call was as follows: Ayes; Ms. Vieth, Mr. Larson, Ms. Dobbs, Ms. Singer, Mr. Johnson, Ms. Palic, and Ms. Ader. Nays; none. Motion carries.

<u>Approval of the Bills:</u> Ms. Dobbs made a motion, seconded by Ms. Singer to approve the Bills Paid Report for the period of March 12, 2022 through April 15, 2022 in the amount of \$765,257.25. Roll call was as follows: Ayes; Ms. Vieth, Mr. Larson, Ms. Dobbs, Ms. Singer, Mr. Johnson, Ms. Palic, and Ms. Ader. Nays; none. Motion carries.

**<u>Report of the Director:</u>** After a brief report on the Library's statistics, Mr. Archer announced a number of library district-related bills recently passed by the Illinois General Assembly that are awaiting the Governor's signature.

He then discussed the all-staff training taking place next month and shared an article that appeared in the Daily Herald regarding the redevelopment plan that the Mundelein Village Board approved for the old Oak Creek Plaza site. Lastly, he shared March email and social media marketing stats as well as information regarding the upcoming Friends Book Sale on May 13-15.

<u>Approve Report of the Director:</u> Mr. Larson made a motion, seconded by Ms. Dobbs, to approve the report of the Director. Roll call was as follows: Ayes; Ms. Vieth, Mr. Larson, Ms. Dobbs, Ms. Singer, Mr. Johnson, Ms. Palic, and Ms. Ader. Nays; none. Motion carries.

**<u>Resources, Services and Long Range Planning</u>:** Mr. Archer reported on the Strategic Planning Update received from Sarah Keister Armstrong noting that the planning process has begun including collecting stakeholder feedback that will be used to inform the library's goals and strategies.

He reported that individual conversations with each of the members of the Board have been conducted as well as a survey of staff that garnered 110 responses. This month a questionnaire to leaders of various community organizations, including municipal/local government bodies, nonprofit organizations, and organizations connected to the local business community will be disseminated. Also the process of drafting a larger community survey has started and that it will go live on May 2 and be open until May 23.

### Village of Libertyville Parking Commission Representative: No report.

**Friends' Representative:** Ms. Dobbs reported that the Friends are having their book sale on May 13-15 and discussed the logistics of the sale being in the basement at the Aspen Drive Library.

### **OTHER BUSINESS**

<u>Post Issuance Tax Compliance Report:</u> Mr. Cerqua explained that the District, as an issuer of governmental bonds, must comply with the federal tax requirements that apply from the date the bonds are issued until the date the bonds, or any refunding bonds, are no longer outstanding. Mr. Cerqua, as the Compliance Officer as set forth in the District's Bond Record Keeping Policy, submits the Post-Issuance Tax Compliance Report each year to report that he has reviewed the documents and records and that the District is in compliance. He noted that no action is required by the Board.

<u>Resolution 2021-2022/24:</u> Mr. Archer explained that this resolution is being presented tonight for a tentatively scheduled summer wine pairing program in July at the Aspen Drive Library where staff from Vigneto del Bino will offer wine pairing options and serve tasting-size portions of summer wines. Ms. Vieth then made a motion, seconded by Mr. Johnson to approve Resolution 2021-2022/24 approving the wine pairing program in accordance with the Library's Alcoholic Liquors Sales and/or Delivery Policy. Select library staff will be learning how to operate the machine over the summer months with the intention of providing access to patrons shortly thereafter.








AGENDA ITEM:	Approval of Resolution 2021-2022/25 Affirming the Library's Participation in the Nonresident Fee Program

The board of each public library is required by Illinois statute to decide annually whether the library will participate in the state's nonresident fee program. Nonresidents are defined as "a person who resides outside the taxing area of a public library" [75 ILCS 16/30-55.60]. Nonresidents have the option to annually purchase a library card at the closest participating library for a fee at least equal to the cost paid by residents.

The CMPLD board has traditionally supported the nonresident fee program even though there are no unserved areas adjacent to the Library's taxing area in which Cook Park or Aspen Drive is the closest library.

Approval of the attached resolution will to affirm the Library's continued participation in the nonresident card program, detailed under Public Act 92-1066, setting the annual fee for the card, using the State Library mathematical formula method, at \$412 effective July 1, 2022 through June 30, 2023.

WHEREAS, the Cook Memorial Public Library District Board of Trustees has traditionally supported the nonresident fee program even though there are no unserved areas adjacent to the Library's taxing area in which Cook Park or Aspen Drive is the closest library; and;

**WHEREAS**, based on the Illinois State Library's mathematical formula attached hereto as Exhibit A, the nonresident fee for the upcoming fiscal year is \$412 per household.

NOW, THEREFORE, BE IT RESOLVED by the Board of Library Trustees of the Cook Memorial Public Library District, Lake County, Illinois:

<u>Section 1</u>: The Library will continue participation in the nonresident card program, setting the annual fee for the card, using the Illinois State Library mathematical formula method, at \$412 effective July 1, 2022 through June 30, 2023.

#### RESOLUTION AUTHORIZING LIBRARY DIRECTOR AND FINANCE DIRECTOR TO EXECUTE REQUIRED PAPERWORK WITH ALL DESIGNATED, ELIGIBLE DEPOSITORY INSTITUTIONS FOR THE FISCAL YEAR JULY 1, 2022 THROUGH JUNE 30, 2023

WHEREAS, from time to time, the Library has excess funds from (a) property tax receipts and other revenue sources which can be invested and/or (b) the maturing of existing investments which can be re-invested; and

WHEREAS, good business sense would dictate investing these funds in interest-bearing accounts and/or certificates of deposit with different financial institutions to obtain the best return on any investment; and

WHEREAS, the Finance Director and Library Director, in conjunction with the Library's investment advisors, deposit library funds in interest-bearing accounts pursuant to the Library's investment policy; and

**WHEREAS**, whenever funds are moved to a different financial institution, the Library Board is required to authorize the deposit of funds with that institution; and

WHEREAS, in order to improve efficiency and eliminate delays in obtaining favorable interest rates for Library funds, the Finance Director and Library Director are authorized to execute such resolutions for all approved, eligible depository institutions for the fiscal year July 1, 2022 through June 30, 2023; and

**WHEREAS**, the Finance Director and Library Director shall notify the Board of all such deposits and changes at the Board's next regular monthly meeting.

**Be It Resolved** by the Board of Library Trustees of the Cook Memorial Public Library District, Lake County, Illinois, as follows:

<u>Section 1</u>: That all of the recitals contained above are hereby incorporated by reference.

<u>Section 2</u>: That the Library Director and Finance Director are authorized to execute all resolutions and documents required by all eligible depository institutions permitted by the Illinois Public Funds Investment Act and the Library's Investment Policy for the fiscal year July 1, 2022 through June 30, 2023.

<u>Section 3</u>: That the officers listed in Section 2 are authorized and empowered to execute such other agreements, including but not limited to, special depository agreements and arrangements regarding the manner, conditions, or purposes for which funds, checks, or items of the Library District may be deposited, collected or withdrawn and to perform such other acts as they deem reasonably necessary to carry out the provisions of this Resolution. ## These invasive trees smell like rotting fish and kill plants. State bans want Bradford pears gone.

Spring is a time for blooming plants and flowering trees. But word to the wise: some of those beautiful blooms might come from invasive species.

One such plant is the Bradford pear, a tree covered in attractive white blossoms with some unattractive features. What was once considered an ornamental and low maintenance decoration for yards and parks has proven detrimental to native plants and has even been banned in some states.

The trees "have little to no value to wildlife and displace native trees," said Steven Long, assistant director of the department of plant industry at Clemson University in South Carolina. Other problems? Their thorns can puncture vehicles tires and their blooms stink, Long said.

## What is a Bradford pear tree?

The Bradford pear, also known as the "Callery" pear, is a popular ornamental tree native to Asia and found throughout the eastern U.S. It is most commonly planted in South Carolina.

"They're in suburban and rural areas, as well as in natural forests," Kelly Oten, assistant professor of forestry and environmental resources at North Carolina State University in Raleigh, said.

The tree is perhaps most famous for the scent of its blooms, which some have compared to rotting fish, urine and baby poop. The fragrant white blooms that appear in early spring draw admirers, despite the offensive smell.

### Where did they come from?

The trees were introduced by the United States Department of Agriculture as ornamental landscape trees in the mid-1960s. They became popular with landscapers because they were inexpensive, transported well and grew quickly.

Considered a sterile hybrid, plant experts did not think the tree would propagate out of control, but scientists developed smaller hybrids designed to compensate for the Bradford pear's weak branch structure.

The trees cannot self-pollinate, but can reproduce with another variety of the Pyrus calleryana species.

The offspring are called Callery pears.

The resulting hybrids are even more problematic than the original Bradford pear tree.

## Are Bradford pear trees harmful?

Yes. The trees choke out other plants, particularly in fallow fields, or empty tracts of land seen as future forests. They can grow to 30 feet tall and the "dead zone" beneath its dense canopy keeps light from reaching other plants.

Because they bloom earlier in the springfrom March to mid-April, Bradford pears overtake resources from surrounding native species.

Long said the trees also increase the cost to maintain land.

"They reproduce prolifically in (once-landscaped) areas and tend to dominate small lots as they are of the first to emerge once a lot is no longer being mowed," he said.

"Callery pears are like a food desert for birds," Oten said. "Caterpillars, which are especially important in the spring when mother birds are getting soft-bodied insects to feed their young, don't feed on them. Because there are no caterpillars that feed on the Bradford pear, there's nothing for them to eat there."

The trees "break easily during ice and wind storms which we have plenty of in (South Carolina)," Long said.

Researchers discovered in the '80s that the tree has a fragile composition. Its signature "steep v crotch" means the tree has a weak structure at the "V" of the branch, yet is stronger in other directions so that it snaps off in areas from old age and high winds.

Drivers should avoid parking their cars beneath a Bradford pear.

### Where is the tree banned?

South Carolina has enacted a ban on new Bradford pear sales effective on Oct. 1, 2024. A ban on the sale and cultivation of the tree in Pennsylvania will also take effect in February of that year.

The tree was placed on the invasive species list in Ohio in January 2018, meaning in-state nurseries and landscapers must phase out selling the trees over the next five years.

Experts say all native species in South Carolina will struggle as long as the Bradford pear tree survives. Even other trees that are not threatened for survival, such as oaks, maples and hickories, are being out-competed.

"I expect many more states will soon follow Ohio and South Carolina's lead on this," Long said.

### How can you get rid of a Bradford pear tree?

At 20 years, the lifespan of a Bradford pear is relatively short, but the species might have reached its tenth generation of production.

"When they cross with another pear and become wild, the offspring does have thorns. This can make it difficult to remove," Oten said.

The thorns are sharp enough to puncture tires, making it difficult to mow down a field of Bradford's.

Fire and some herbicides are alternative options for elimination, but fire has been shown to aid resprouting.

The best weapon, according to experts, is to cut down the trees, and some states are providing incentives for removal. Clemson University in South Carolina has offered to exchange five cut-down Bradford pears with native trees.

The North Carolina Forest Service Urban and Community Forestry Program advises people to remove or treat the stump with an herbicide to prevent it from sprouting new trees and to grind down the stump before placing a new tree in the same spot. Some landscaping companies provide stump-grinding services, according to the program.

Most importantly, homeowners should avoid planting the tree altogether and instead plant native species.

"We have plenty of native trees that have very similar blossoms, such as the flowering dogwood, black cherry, and serviceberry," Oten said.
