Director's Narrative Report August 2022

David Archer, Library Director

All-Staff Training

Both library locations will be closed the morning of Friday, September 9 for staff training. Agenda includes:

- Active shooter training
- Annual state-required sexual harassment training.
- Department meetings.

Odds & Ends

- Our Safety Team has updated the Library Emergency Manual which has 16 chapters covering a
 variety of emergency situations that staff may face (e.g., power outages, tornado warnings,
 active shooter, missing child, mechanical emergencies, etc.). Our 'safety quiz' is also being
 updated, which gives new hires an opportunity to tour each library building so they can note the
 location of various safety tools such as fire extinguishers, emergency exits, 'secure spaces,' and
 panic buttons
- Library closed for Labor Day on Monday, September 5. Open Sunday, September 4.
- National Night Out in Vernon Hills was a huge success. Over the span of the evening, the Bookmobile had almost 200 visitors in the vehicle, with many more stopping the CMPLD table outside to spin the prize wheel.
- The Bookmobile will be appearing at the Village of Vernon Hills Public Works Department Open House on Tuesday, August 16 from 4-7pm.
- Aspen Drive Library is gearing up for back-to-school on Thursday, August 19. Aspen attracts a large number of students after school who are greeted by our two After-School Associates, whose sole job is to engage and welcome students.
- We have a monthly YouTube series called Bookies TV, where Popular Services staff talk about what they've been reading lately. We also host a quarterly "Book Buzz" videos series on YouTube, where new titles are highlighted for the upcoming season.
- Children's Program Coordinator Jenn Jensen brought back the tween and teen volunteer
 program after a two-year hiatus with 20 volunteers. Volunteers assist staff with library
 programs, prepare crafts and other support functions. Additionally, our Teen Tech Tutors
 (Grades 9-12) provide 1-on-1 tech help sessions at the library on Saturdays at both locations.
- Jenn also started an initiative this summer of working with specially selected high school students to offer programming in areas that we know would be of interest, but don't have experienced staff. Jenn mentors the students through the process of organizing the content of the program as well as how to present to younger kids. The students offered programs focusing on coding, Bollywood dancing, and TikTok dances. These programs were popular, and we hope to continue offering these types of programs.
- CMPLD was invited again this year to attend Family Night at the Hawthorn School for Young Learners on August 16. Student Services Coordinator Amy vanGoethem and Assistant Children;s Manager Heather Beverley will attend to talk to families about the library and our services, as well as to provide information on and applications for library cards.

AUGUST 2022

The community engagement piece of the strategic planning project has largely wrapped up. Following this meeting, we anticipate distributing a draft for review and discussion at the full board level, as well as providing an asynchronous opportunity for all library staff to provide feedback.

Approval of the attached resolution authorizes the deletion of 25 video/audio recordings of regular board meetings and committee meetings held from April 21, 2020 to December 15, 2020.

Amendments to the Illinois Open Meetings Act ("OMA") permitted virtual meetings without the physical presence of a quorum of board members during the COVID pandemic provided that a verbatim recording was made available to the public and kept for no less than 18 months after the meeting was held.

The OMA permits governmental bodies to delete these recordings after 18 months provided that written minutes have been approved by the board.

AUTHORIZING THE DESTRUCTION OF VERBATIM RECORDINGS OF OPEN MEETINGS CONDUCTED VIA ZOOM FOR THE COOK MEMORIAL PUBLIC LIBRARY DISTRICT BOARD OF LIBRARY TRUSTEES

WHEREAS, the Illinois Governor issued COVID-19 Executive Order No. 5, dated March 16, 2020 which allows public bodies to conduct meetings electronically without having to comply with the physical quorum requirement or the conditions for participating electronically in a meeting; and

WHEREAS, on June 12, 2020, the Governor issued Public Act 101-0640 amending the Open Meetings Act ("OMA") which allows public bodies to hold "an open or closed meeting by audio or video conference without the physical presence of a quorum of the members" during a public health disaster as long as they (1) make a local determination that a fully in-person meeting is not practical or prudent and (2) follow all of the other remote meeting requirements of section 7(e) of the OMA for that meeting; and

WHEREAS, the OMA's new remote meeting provisions during a disaster requires public bodies to create a verbatim audio or video record of any remote open meeting which must be made available to the public; and

WHEREAS, these verbatim records are subject to the same retention provisions of the OMA and must be kept for at least 18 months after the meeting was held, in the same manner that verbatim recordings of closed sessions are retained; and

WHEREAS, the Open Meetings Act permits governmental bodies to destroy the verbatim record of closed sessions without notification to or the approval of a Records Commission or the State Archivist not less than eighteen (18) months after the completion of the closed session recorded, but only after:

- 1. It approves the destruction of a particular recording; and
- 2. Approves written minutes of the closed session; and

WHEREAS, for the verbatim recordings of the open meetings set forth in Section 2 of this Resolution, at least eighteen (18) months have passed since the completion of those meetings, and the Board of Library Trustees have approved written minutes for each of the open meetings set forth in Section 2; and

WHEREAS, the Board of Library Trustees approve the destruction of the verbatim recordings for those open meetings listed in Section 2 of this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Cook Memorial Public Library District, Lake County, Illinois as follows:

SECTION 1: That the recitals set forth above are incorporated as Section 1 of this Resolution.

SECTION 2: That the audio verbatim recordings of the following open meetings are hereby approved for destruction:
