AGENDA ITEM: Approval of Resolution 2024-2025/6 Accepting Bids and Awarding Contracts for

the Cook Park Library Children's Renewal Project.

At this evening's meeting, Tom Featherstone of Featherstone Inc. and Tiffany Nash of Product Architecture + Design will be joining virtually to review trade and furniture bids for the Cook Park Library Children's Renewal Project. The Board will be voting to approve a resolution to accept these bids and proceed with the next phase of the project.

The Library publicly advertised for sealed bids for this project on October 19, which were subsequently opened and announced at the Cook Park Library on November 19. Following this, Featherstone and Product reviewed the bids and provided their recommendations, which are detailed as Exhibits A & B in the attached resolution.

You'll note that the proposed project budget has increased from \$970,000 to \$1,065,000 due to the following factors, which will be discussed at tonight's meeting:

- 1. **Higher-than-expected electrical bids**: These exceeded original estimates, impacting the overall budget.
- Increased furniture costs: Furniture and shelving costs exceeded initial projections. Architects
 and staff have worked to reduce expenditures by eliminating some optional purchases and
 choosing lower cost alternates.
- 3. **Extended project timeline**: The project completion date has been extended by three weeks, now anticipated to be April 17, 2025, resulting in higher construction management costs.

Parliamentary Guidance:

- If no changes are needed to the resolution, a member may state: "I move to approve Resolution 2024-2025/6."
- If changes are desired, the resolution must first be "motioned" and "seconded" before any amendments can be proposed. A trustee can then formally introduce an amendment by stating: "I move to amend the motion for Resolution 2024-2025/6 by modifying the following sections."
 Another trustee must second the motion before the board can consider and discuss the proposed changes.

RESOLUTION ACCEPTING BIDS AND AWARDING CONTRACTS FOR THE COOK PARK LIBRARY CHILDREN'S RENEWAL PROJECT

WHEREAS, the Board of Library Trustees ("Board") of the Cook Memorial Public Library District ("Library") approved a four-year Strategic Plan on December 22, 2022, based on valuable community input; and

WHEREAS, among the key goals of the Strategic Plan are to "Reimagine the Cook Park Library Children's department to expand the potential level of engagement and interaction, particularly among early learners;" and

WHEREAS, on May 21, 2024, the Board approved Resolution 2023-2024(21), authorizing Product Architecture + Design ("Architects") to prepare drawings and engineering documentation for improvements to the Cook Park Library Children's area ("Project"); and

WHEREAS, the Architects collaborated with Library staff to reimagine the Children's space, incorporating vibrant new furniture and creating a flexible, engaging, and efficient design to enhance its functionality and appeal; and

WHEREAS, on July 16, 2024, the Board approved Resolution 2024-2025(1) Authorizing Featherstone Inc. ("Construction Manager") to proceed with preconstruction services for the Project; and

WHEREAS, on October 19, 2024, pursuant to the Public Library District Act of 1991, 75 ILCS 16/40-45, the Library publicly advertised for sealed bids for the Project; and

WHEREAS, bids for separate construction contracts were publicly opened and announced at the Cook Park Library on November 19, 2024, and subsequently reviewed by the Construction Manager, who has recommended the selected vendors and bid amounts as outlined in the Letter of Bid Award Recommendation detailed in Exhibit A; and

WHEREAS, bids for furniture and shelving contracts were publicly opened and announced at the Cook Park Library on November 19, 2024, and subsequently reviewed by the Architects, who has recommended the selected vendors and bid amounts as outlined in the Letter of Bid Award Recommendation detailed in Exhibit B; and

WHEREAS, the Board of Library Trustees, after careful consideration, has determined that the firms detailed in Exhibits A and B are the lowest responsible bidders.

NOW, THEREFORE, BE IT RESOLVED by the Board of Library Trustees of the Cook Memorial Public Library District, Lake County, Illinois, as follows:

<u>Section 1</u>. The Board approves a total revised budget of \$1,065,000 for the Project, of which \$69,750 has been spent on architectural, design, and engineering services as authorized by previous board action.

<u>Section 2</u>. The Board finds the firms for each of the base bid and recommended alternate contracts as detailed in Exhibit A are the lowest responsible bidders totaling \$467,590.

<u>Section 3</u>. The Board finds the firms for each of the furniture bids and recommended as detailed in Exhibit B are the lowest responsible bidders totaling \$296,127.84.

<u>Section 4</u>. The Board authorizes the Board President and Secretary to execute base bids and defined alternates with the lowest responsible bidders as set forth in Exhibits A & B subject to final review of the contracts by the Library Director and/or Library Attorney.

<u>Section 5</u>. The Board authorizes the President and Secretary to execute a \$127,453 contract with Featherstone, Inc. for construction management services for the Project, as detailed in Exhibit A.

Memorandum: Recommendation to Award

Cook Park Library Furniture: Interior Renovation

Board of Trustees Cook Memorial Public Library District 413 N. Milwaukee Avenue Libertyville, IL 60048

Trustees:

On November 19 at 1:00 pm, the library accepted and opened bids for 2 separate furniture bid packages for the interior renovation project at the library.

Product Architecture + Design confirmed with the low bidders that they included everything.

Bid Package 1: Open Lines

We received 3 bids for furniture that is considered to be "open lines", meaning that these manufacturers will allow any dealer to sell and install their products. The low bidder Thomas Interiors with a total base bid of \$39,525.68. We have reviewed their bid with them and find it to be complete. Bids are listed below for this package.

Continua Interiors	\$41,539.04
Thomas Interiors	\$39,525.68

Bid Package 2: Shelving, end panels, 3 Branch furniture

This package was for new shelving and shelving parts, new end panels, and 3 Branch custom items. There was one bid from LFI for of \$220,862.00.

KI furniture: KI sells direct to owners and doesn't require a dealer. They provided a quote of \$16,307.26.

VS furniture: Continua Interiors VS furniture can only be sold by one local dealer. They provided a quote of \$16,165.50. This includes some seating, tables, and storage units in the youth area.

Steelcase furniture: Interiors for Business: Steelcase furniture can only be sold by a few dealers. Interiors for Business is a preferred dealer for this product. They provided a quote of \$3,267.40 for some chairs in the teen area.

The total project budget is listed below, assuming that the Board approves the dealers recommended by Product.
